

OFFER AGREEMENT
on SCIF-2018 Conference Participation
(May16-18, 2018, Batumi, Georgia)

The Company with a limited liability “SCIF Congress”, hereinafter referred as the Contractor, in the person of a Director, L.V. Khalimon, acting on the basis of the Articles of Association, hereby offer to any individual or legal person, hereinafter referred as the Customer, to participate in SCIF-2018 International Conference (May 16-18, 2018, Batumi, Georgia), hereinafter referred as the Conference.

1. GENERAL PROVISIONS

1.1. This Agreement shall be considered as the public offer and be not subject to signing (in accordance with Articles 633, 641 and Section 63 of the Civil Code of Ukraine). The Public Offer Agreement shall be legally valid as the contract executed in hard copy. This Agreement shall contain all and any essential terms and conditions of the remote payment for the services, i.e. by means of Internet.

1.2. If the individual (or the legal person) accepts the terms and conditions of this Agreement (i.e. the Public Offer), such accepting person shall become the Customer. Payment of 100% of the services cost rendered hereunder shall be considered as the offer acceptance. The partial payment shall not empower the payer to become the Customer hereunder and result in no obligations of the Contractor relating such payer.

1.3. The Contractor shall undertake to arrange participation of the Customer’s representatives in the Conference events in accordance with the service package paid.

1.4. The Contractor shall reserve the right to amend and alter this Agreement through placement of the update information on scif2018.com web-site. In the case of any changes in the time frame of the Conference for any reasons beyond the Contractor’s control the Customer shall be entitled on refunding of the monetary assets in amount of 90% of the services cost or shall confirm participation thereof in the Conference subject to any amendments or alterations.

2. OBLIGATIONS OF THE PARTIES

2.1 The Contractor’s obligations:
the Contractor shall be obliged:

2.1.1 to arrange participation of the registered representatives of the Customer in the Conference events;

2.1.2 to provide to the Conference Participants the delegatory support required for activity at the Conference;

2.1.3 to arrange complete servicing of the Participants.

2.2. The Customer shall be obliged:

2.2.1 to pay for participation in the Conference according to the article 3 of this Contract within 5 banking days upon the date of the invoice issuing by the Contractor.

3. AGREEMENT PRICE AND PAYMENT TERMS

3.1 Cost of participation in the Conference is stated in euro according to the specification provided for by the Supplement №1 to this Agreement.

3.2 The price shall include the service charge for arrangement of participation of the Customer representative(s) in the events of the Conference according to the Specification being an integral part hereof (ref. Supplement №1).

3.3 The Customer shall pay by means of transfer of the funds to the settlement account of the Contractor on the basis of the invoices issued.

4. RESPONSIBILITY OF THE PARTIES

4.1 The Parties shall bear responsibility in accordance with the regulations of the applicable legislation of Ukraine.

5. AGREEMENT VALIDITY

5.1 This Agreement shall come into force upon full payment for the services rendered and be valid till complete performance of the terms and conditions hereof.
